



**InfraMation FLIR® E8 Grand Prize Drawing
OFFICIAL RULES**

VOID WHERE PROHIBITED.

1. ELIGIBILITY: The InfraMation FLIR E8 Grand Prize Drawing (“the Drawing”) is only open to individuals who are: (1) legal residents of the United States (US) residing within the US (including Puerto Rico and the US Virgin Islands); and (2) who are eighteen (18) years of age or older as of September 28, 2015 (the “Entrant”). Employees of Sponsor (as defined below), and its respective parent companies, affiliates, subsidiaries, officers, directors, employees, contractors, representatives and agents, and each of their respective immediate family or household members (collectively the “Released Parties”) are not eligible to enter the Drawing.

2. HOW TO ENTER: Each Entrant must agree to and abide by these Official Rules to be eligible for the drawing for a chance to win the FLIR E8 thermography infrared camera (the “Grand Prize”). An Entry gives the Entrant one (1) chance to win the Grand Prize, unless awarded a Bonus Entry. Limit one (1) Entry per Entrant (or email address), or two (2) if awarded a Bonus Entry. All Entries received in excess of the stated Entry limit, or any Entry that is intended to circumvent the stated limit or that is incomplete, forged, or contains inaccurate information, will be disqualified. DRAWING ENTRY PERIOD: An Entry will only be accepted if received on or between **September 30, 2015 at 12:00:01 AM Eastern Time (ET) and September 23, 2016 at 11:59:59 PM ET** (the “Entry Period”). The Sponsor’s Website database clock will be the official timekeeper for the Drawing. Any Entry that is received outside of the Entry Period will be disqualified and discarded.

4. GRAND PRIZE, ARV, AND ODDS OF WINNING: The Grand Prize shall consist of one (1) FLIR E8 thermography infrared camera (total approximate retail value (ARV) of Five Thousand Nine-Hundred Ninety-Five Dollars (\$5,995.00); however, Sponsor reserves the right, in its sole discretion, to substitute an infrared camera of equal or greater value in lieu of awarding a FLIR E8 infrared camera. The odds of winning the Grand Prize depend on the number of eligible Entries received during the Entry Period.

5. SELECTING THE GRAND PRIZE WINNER: The Grand Prize shall be awarded to a randomly selected qualified Entry received during Entry Period (the “Grand Prize Winner”) selected by Sponsor (or, in Sponsor’s sole discretion, by a representative of Sponsor) on or about September 27, 2016.
